Mr. Nagayama:

We, Vitaly Pilkin and Vladimir Miroshnichenko (hereinafter called as 'applicants'), over the last three years repeatedly submitted to Sony Corporation and many other Sony Group companies arguments and proofs evidencing multiple offenses provided for by the US law which were committed by Sony Group companies and Hogan Lovells in order to steal our patent on the invention which is used in game console PlayStation Vita.

Nevertheless, management of Sony Corporation and other Sony Group companies have not carried out bona fide corporate investigation of said crimes, did not punish or replace employees of Sony Group companies liable in commission of said crimes, did not alert the US Department of Justice (DOJ) about said crimes, concealed from DOJ said crimes and by doing that management of Sony Corporation and other Sony Group companies defrauded the United States.

The longer Sony Group delays the resolution of the problem, the more Sony Group aggravates the situation and thereby puts at risk reputation of Sony Group.

The longer Sony Group will be idle, the more persons, entities, organizations and government officials around the world will learn the truth about multiple crimes committed by Sony Group companies and Hogan Lovells, the details of which are disclosed in draft of the complaint (enclosed) and are also available on the website www.justicewanted.org

Management of Sony Group does not want to understand the following simple things: since (1) too many people were involved in commission of said crimes with different interests to the results of said crimes, (2) Sony Group companies and Hogan Lovells did not resolve the dispute with applicants, (3) applicants have no choice but to spread the truth about said crimes exactly as long as it takes for the triumph of truth and justice, (4) Sony Group and Hogan Lovells are not able to wrongfully influence the whole American justice system in order to avoid responsibility for committed crimes, hence, it is absolutely impossible to prevent a fair criminal investigation of said crimes and therefore sooner or later the justice will prevail.

It is surprising to observe when a large company such as Sony Corporation for the theft of the patent on the invention is ready to commit multiple crimes and risk its reputation. Until we faced aforementioned situation, we could never even imagine that such a thing could be at all.
