

**Congressman:**

There are reliable proofs evidencing that:

- Sony and Hogan Lovells entered into a corruption conspiracy with the Russian government officials.
- The Russian law enforcement agencies concealed corruption of the Russian government officials committed by Sony and Hogan Lovells in Russia.
- Sony and Hogan Lovells committed numerous US federal offenses.
- Sony and Hogan Lovells conspired to conceal and concealed commission of said US federal crimes.
- Sony and Hogan Lovells conspired to defraud the United States.
- Sony Corporation, Sony Interactive Entertainment, Sony Electronics as well as President and CEO of Sony Corporation Kazuo Hirai, Chairman of the Board of Sony Corporation Osamu Nagayama, CEO of Sony Electronics Takakiyo Fujita, CEO of Sony India Kenichiro Hibi, President of Sony Europe Shigeru Kumekawa and many others were knowingly and willfully involved in commission of the US federal crimes and defrauding the United States.
- Hogan Lovells US LLP, Hogan Lovells International LLP, Hogan Lovells (CIS) as well CEO of Hogan Lovells Stephen Immelt, Deputy CEO of Hogan Lovells David Hudd, more than 700 partners of Hogan Lovells and many other lawyers of Hogan Lovells were knowingly and willfully involved in commission of the US federal crimes and defrauding the United States.
- In violation of federal statute, the Justice Department concealed said crimes committed by Sony Group companies, Hogan Lovells, their top managers, employees, partners and lawyers.
- In violation of federal statute, the Justice Department aided Sony Group companies, Hogan Lovells, their top managers, employees, partners and lawyers to avoid liability for committed the US federal offenses.

Aforementioned information is confirmed by reliable evidence disclosed in the complaint filed with the US District Court for the DC November 13, 2017 and available on the website [www.justicewanted.org](http://www.justicewanted.org)

It follows from the foregoing at least that (1) the Justice Department deliberately violated the constitutional principle of equal justice under law, (2) the Justice Department conspired to defraud the United States and (3) the selective application of the US extraterritorial laws by the Justice Department undermines the international weight of said laws and thus the national interests of the United States.

Since oversight over the activities of the Justice Department is the privilege of the Congress and the complaint contains enough reliable evidence of wrongdoing committed by the Justice Department (see Counts Twenty Three, Twenty Four and Twenty Five of the complaint, pages 101 – 112), therefore, I believe there are enough legal grounds to initiate an investigation of the wrongdoing committed by Justice Department.
